ORDINANCE NO 1

AN ORDINANCE ESTABLISHING FIRE AND SERVICES MEMBERSHIP FEES AND SERVICE CHARGES FOR THE KARNS VOLUNTEER FIRE DEPARTMENT.

WHEREAS, The Karns Volunteer Fire Department provides fire protection and other emergency response services to the citizens of Ball Camp, Solway, Hardin Valley and Karns Communities and,

WHEREAS, The Karns Volunteer Fire Department wishes to maintain its high level of service to the citizens of Ball Camp, Solway, Hardin Valley and Karns Communities and,

WHEREAS, Membership fees and service charges are a means of spreading the cost of maintaining a fire and emergency response department to the users of the department, and

NOW THEREFORE IT IS FURTHER ORDAINED that The Karns Volunteer Fire Department Board of Directors hereby approves the fire service membership fees of 0.07 cents per square foot, and

BE IT FURTHER ORDAINED that the fees for NON-MEMBERS WILL BE SET AT:

Hazardous Materials	\$ 950 per engine, per hour; plus all associated clean-up costs
Smoke Alarm No Fire	\$ 450
Carbon Monoxide	\$ 450
Emergency Medical Call	\$ 150
All Non-Listed Emergency Calls	\$ 950 per engine, per hour

All Non-Listed Emergency Calls	\$ 950 per engine, per hour

BE IT FURTHER ORDAINED that the Corporate President and Treasurer are hereby directed to issue invoices for fire memberships and service fees, and to collect such fees on behalf of the Karns Volunteer Fire Department and to deposit such fees in the Karns Volunteer Fire Corporate Account, which shall be used to purchase equipment, training, and other services and supplies as deemed necessary for the Karns Volunteer Fire Department.

SEVERABILITY CAUSE. If any section, provision, or part of this ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole, or any section, provision, or thereof not adjudged invalid or unconstitutional.

WHEN EFFECTIVE. This ordinance shall be in effect after its final passage, approval and beginning the first day of January 2011.
